1. NEW APPLICATIONS:

No business was discussed.

2. PUBLIC HEARINGS:

4. INLAND WETLANDS ENFORCEMENT OFFICER'S REPORT:

Ms. Malanca informed the Commission that the Korfels at 81 Bsullak Road were still in compliance. She also notified the Commission that the Sugaraks on Eddy Road had just started their required work.

5. APPROVAL OF MINUTES:

A. May 4, 2010 regular meeting minutes.

MOTION Ms. Sullivan, second Mr. Ream, to approve the minutes of the May 4, 2010 regular meeting as written; unanimously approved.

6. CORRESPONDENCE:

Denise Linden of 14 Bridle Drive addressed the Commission and submitted a letter from her attorney dated May 28, 2010 requesting evidence of application and approval for the use of Lot B Bridle Drive as an access way for work to be performed on an abutting property. Ms. Malanca stated that she would review the tapes of the meeting again.

Mr. Greaser distributed a copy of *Connecticut Wildlife* for the Commission's perusal.

7. ANY OTHER BUSINESS LEGAL AND PROPER TO COME BEFORE THE COMMISSION:

A. Show Cause/Cease and Correct – Worth, K.T., 315 New Hartford Road.

Ms. Worth was not present at the meeting to discuss this issue. Ms. Malanca noted that this was the second time that Ms. Worth had not been present for the Show Cause Hearing regarding her property. Ms. Malanca requested that the Commission direct her as to how to proceed with this issue.

MOTION Mr. Labbe, second Ms. Sullivan, to authorize the Inland Wetlands Enforcement Officer, Rista Malanca, to advise Ms. Worth that a decision would be made on the matter of **Show Cause/Cease and Correct – Worth, K.T., 315 New Hartford Road** at the July 6, 2010 regular meeting whether or not Ms. Worth was in attendance; unanimously approved.
