Free Energy Audit for Your Home*

The Service Typically Includes:

- A blower-door test which pinpoints critical drafts and air leaks; the technician will professionally seal them during the visit
- A test to assess air leaks within the ductwork system; the technician will seal significant leaks
- Hot water-saving measures including installation of low-flow showerheads and faucet aerators
- Rebates for qualifying air conditioning systems and for replacement of inefficient appliances with qualifying energy-efficient models
- Installation of energy-efficient compact fluorescent light bulbs
- Incentives for insulation upgrades
- A "kitchen table wrap-up" where the technician will review the work that was done in your home and tell you about additional resources that can help you save energy and money

- 1) Contact town hall to be placed on the audit fee reimbursement list (860-379-8285)
- 2) Sign up for an energy audit through CL&P
- 3) Sign up for at least 50% Clean Energy Option
- 4) Bring your paid receipt for the completed audit and a copy of your electric bill showing you've signed up for a clean energy option to town hall and you will be reimbursed for the \$75 audit fee
